We do not share, rent, hire or disperse your data to any other third party, unless required to do so by law. You may ask for a copy of any data we hold by making a request to the Chair. Should you cease to be a member we will hold your data for a period of one year, after which it will be deleted unless you give us permission to continue to hold it.
